SUBSTANTIVE CHANGE RELATED TO ADDITIONAL LOCATION

Dallas Theological Seminary - Dallas, TX

- To acknowledge that the school is closing two additional locations, effective December 31, 2021: the site at 1849 Perry Hill Road, Montgomery, AL 36106 (Heritage Baptist Church) and the site at 107 18th Street, Tuscaloosa, AL 35401 (Forrest Lake Baptist Church). Since both locations are approved to offer half or more of approved degrees but not any complete degrees, no teach-out plan for either is required. The notifications for these two closures indicate, however, that the educational needs of the few students currently enrolled at these sites are being appropriately addressed through a variety of options. These closures meet the criteria for notifications described in *Policies and Procedures*, IV.E.2. [Commission staff action 4/21/2021 on behalf of the Board of Commissioners.]
