ACTION TAKEN RELATED TO PUBLIC SANCTION (WARNING, PROBATION, OR SHOW CAUSE)

Previous versions of the Standards of Accreditation and the Policies and Procedures used the term "notation" to refer to instances where a member school was not meeting or not fully meeting one or more standards. In June 2020, the membership and Board adopted a new set of Policies and Procedures that replace the term "notation" with "warning," describing the new term as follows (III.G): "Issuing a warning is a public action (the lowest level of three public sanctions; see III.H-I for the other two) that is taken when the Board determines that an accredited school substantially meets the standards but is at risk of not meeting one or more standards." Per the Board-approved implementation procedures, any school that received a notation prior to June 2020 must address that notation in light of the newer Standards of Accreditation (effective July 1, 2020).

International Theological Seminary - West Covina, CA

- 6. To impose probation for a period of 24 months (June 2023 to June 2025), as a result of the school not meeting the following Commission Standard (per *Policies and Procedures*, III.H): Standard 10.3. The school is at risk of not having "sufficient and stable financial resources to achieve its mission with educational quality and financial sustainability." The school must submit a report by the 1st of April 2025, documenting progress toward financial sustainability, including a financial plan that is "realistic, holistic, and sustainable" (see <u>Guidelines for Understanding Standard 10.3 on Finances</u> for additional guidance). The school's FY 2022-2023 and FY 2023-2024 audits, management letters (if available), analysis of the FY 2024-2025 operating revenues and expenditures, and budget projections for FY 2025-2026 must be appended to the report (see Standards 9.3 and 10.3).
- 7. To authorize a focused visit prior to the end of the period of probation (no later than April 15, 2025) to make a recommendation regarding whether the Board of Commissioners should remove probation or take an adverse action, i.e., withdrawal of accreditation (*Policies and Procedures*, III.J). [Effective June 23, 2023, per *Policies and Procedures*, VI.A.5 (Board Procedure on Effective)
 - [Effective June 23, 2023, per *Policies and Procedures*, VI.A.5 (Board Procedure on Effective Date of Accreditation Decisions); cf. VII.A.4-5 and VIII.A(.1-3)]

New York Theological Seminary - New York, NY

 To issue a Show Cause Order. The school should submit a report no later than the 1st of April 2024, demonstrating why accreditation should not be withdrawn. This report should demonstrate that the school meets Standard 10.3 and has "sufficient and stable financial resources to achieve its mission with educational quality and financial sustainability." The report should include the FY 2022 and FY 2023 Audit Reports, the school's analysis of its FY 2022 and FY 2023 operating revenues and expenditures, updated budget projections for FY 2024 and FY 2025, and a report on the school's progress toward balancing its operating budget, increasing its reserves, and replenishing its investments. Failure to submit a satisfactory report will lead to withdrawal of accreditation (*Policies and Procedures*, III.J).

Presbyterian Theological Seminary in America - Santa Fe Springs, CA

- 6. To impose the following warnings because the school, while substantially meeting the Commission *Standards of Accreditation* as a whole, is at risk of not meeting the following specific standards. The school has two years to address these warnings adequately, or the Board will take other appropriate action as described in the *Policies and Procedures*, III.G-J:
 - a. <u>Standards 2.6-7 on Evaluation</u>: The school has insufficient evaluation processes and practices for its educational programs and must submit a report by the 1st of April 2025, providing clear documentation of how it fully meets all parts of Standard 2.6-7 for each degree program.
 - b. <u>Standards 9.6-8 on Shared Governance</u>: The school insufficiently demonstrates an expression of shared governance in which the school's governing body delegates to the faculty appropriate authority to oversee, design, implement, evaluate, and improve the school's educational programs and policies in collaboration with other appropriate parties. The school must submit a report by the 1st of April 2025, documenting the establishment of a governance model that ensures that faculty, understood as those charged with teaching the majority of the curriculum, exercise appropriate authority in light of their expertise, and that governance is shared appropriately across the institution.

Seminario Evangélico de Puerto Rico - San Juan, PR

The school is at risk of not having "sufficient and stable financial resources to achieve its mission with educational quality and financial sustainability." The school must submit a report by the 1st of April 2025, documenting progress toward financial sustainability, including a financial plan that is "realistic, holistic, and sustainable" (see <u>Guidelines for Understanding Standard 10.3 on Finances</u> for additional guidance). The school's FY 2020-2021, FY 2021-2022, and FY 2022-2023 audits, management letters (if available), analysis of the FY 2023-2024 and FY 2024-2025 operating revenues and expenditures, and budget projections for FY 2025-2026 must be appended to the report (see Standards 9.3 and 10.3).
- 2. To authorize a focused visit prior to the end of the period of probation (no later than April 15, 2025) to make a recommendation regarding whether the Board of Commissioners should remove probation or take an adverse action, i.e., withdrawal of accreditation (*Policies and Procedures*, III.J).
