# **Abstracted Summary of Final Actions: February 2024**

The report is to include the FY 2022-23 and FY 2023-24 audits and management letters (if available), the school's analysis of its FY 2024-25 operating revenues and expenditures, and budget projections for FY 2025-26 and FY 2026-27 (see Standard 10.3).

#### Seminario Evangélico de Puerto Rico - San Juan, PR

- 1. To acknowledge notification of action taken by Middle States Commission on Higher Education (MSCHE), received November 20, 2023, to place the school on probation due to concerns related to planning, resources, and institutional improvement.
- 2. To take no further action at this time as the Board has already placed the institution on probation (June 2023) and required a teach-out plan in anticipation of the subsequent report on finances (April 2025) from that action.

## Southwestern Baptist Theological Seminary - Fort Worth, TX

- 1. To acknowledge the notification that Southwestern Baptist Theological Seminary has been placed on warning by the Southern Association of Colleges and Schools Commission on Colleges, effective June 23, 2023.
- 2. To adjust the date of the upcoming report *to* July 1, 2024 (*from* July 1, 2025), regarding the governing body's authority for managing the school's finances and other assets (see Standard 9.3); evidence that budgeted and actual revenues and expenditures are realistic, holistic, and sustainable (see Standard 10.3); and evidence the school's endowment investment and spending strategy considers its mission, planning, financial sustainability, and potential impact on the future (see Standard 10.5). The report is to include the FY 2021-22 and FY 2022-23 audits and management letters, the school's analysis of its FY 2023-24 operating revenues and expenditures, and three-to-five-year budget projections.

### St. Mary's Seminary and University - Baltimore, MD

- 1. To acknowledge the notification that Saint Mary's Seminary and University has continued on warning by the Middle States Commission on Higher Education, effective June 22, 2023.
- 2. To require a report by the 1<sup>st</sup> of April 2024, regarding planning with attention to how the planning process informs the resourcing of strategic priorities and institutional improvement (see Standards 2.2-5).

## Starr King School for the Ministry - Oakland, CA

To require a teach-out plan by the 1<sup>st</sup> of September 2024, given that the US Department of Education placed the school on heightened cash monitoring for "failure of financial responsibility under the Department's regulations" and specifically for a "missing or late audit." This provisional teach-out plan must address each of the five criteria included in *Policies and Procedures*, III.L.2. The school is requested to consult their Commission liaison for guidance in the process.

#### Westminster Theological Seminary - Philadelphia, PA

- 1. To acknowledge the notification that the school has been placed on warning by the Middle States Commission on Higher Education, effective June 22, 2023.
- 2. To remind the school of the report required "by the 1st of April 2024, addressing institutional and programmatic planning and evaluation. The report is to address Standards 2.5-7 for each of the school's programs including a description of the sustained process of analyzing and reflecting upon the gathered data, and evidence of how the analysis of the data shapes educational and institutional improvement (closing the loop) (see Standards 2.5-7). A link to the web posting of the current statement of educational effectiveness is to be included (see Standard 2.8). The school is encouraged to consult the Board's *A Reflective Guide to Effective Evaluation for Theological Schools*."

# ACTION TAKEN RELATED TO PUBLIC SANCTION (WARNING, PROBATION, OR SHOW CAUSE)

# Claremont School of Theology - Los Angeles, CA

To issue the following warning because the school, while substantially meeting the Commission *Standards of Accreditation* as a whole, is at risk of not meeting the following specific standard. The school has two years to address this warning adequately, or the Board will take appropriate action as described in *Policies and Procedures*, III.G-J, which usually means imposing probation. [Effective February 26, 2024, per *Policies and Procedures*, VI.A.5 (Board Procedure on Effective Date of Accreditation Decisions); cf. VII.A.4-5 and VIII.A.1-3]

Standard 10.3 on Financial Resources. The school is at risk of not having "sufficient and stable financial resources to achieve its mission with educational quality and financial sustainability." The school must submit a report by the 1<sup>st</sup> of November 2025, documenting progress toward financial sustainability, including a financial plan that is "realistic, holistic, and sustainable" with a credible plan to address any deficiencies going forward. The school's FY 2023 and FY 2024 audits, along with any management letters (if available), must be appended to the report. The report should also address how the \$7.7M arbitration award will be used and the role of the board in planning and governance related to the financial crisis.

#### International Theological Seminary - West Covina, CA

To require a teach-out plan by the 1<sup>st</sup> of July 2024, because the institution has been placed on probation by the Board (*Policies and Procedures*, III.L.1). The teach-out plan should follow the criteria for teach-out plans described in *Policies and Procedures*, III.L.2.

### Pontifical College Josephinum - Columbus, OH

- 1. To receive the report required in February 2022 regarding the warning related to Standards 2.1-4 on planning, including information related to Standards 7.3 (enrollment), 9.6-8 (shared governance), 10.3 (balanced budgets), and 10.5 (prudent endowment draws).
- 2. To remove the warning related to Standards 2.1-4 [i.e., the school is accredited in good standing].
- 3. To require a report by the 1<sup>st</sup> of November 2025, documenting continued progress as anticipated in the strategic and operating plans in increased enrollment, sustained balanced budgets, and regular prudent endowment draws (see Standards 7.3, 10.3, and 10.5).

## Seminario Evangélico de Puerto Rico - San Juan, PR

To require a teach-out plan by the 1<sup>st</sup> of July 2024, because the institution has been placed on probation by the Board (*Policies and Procedures*, III.L.1). The teach-out plan should follow the criteria for teach-out plans described in *Policies and Procedures*, III.L.2.

## United Theological Seminary of the Twin Cities - St. Paul, MN

- 1. To receive the report required in January 2023 regarding the warning related to Standards 10.3-6 on financial resources.
- 2. In light of incremental progress, to remove the warning related to Standards 10.3-6 [i.e., the school is accredited in good standing].
- 3. To require a report by the 1<sup>st</sup> of November 2024, documenting continued progress toward financial sustainability. The report is to include an update on the school's progress toward anticipated enrollment growth, reducing and eliminating its operating deficits including negative net revenue budgeting (see Standard 10.3), the current tuition revenue and scholarship strategy (see Standard 10.4), the continued preservation and utilization of endowment draws (see Standard 10.5), and the donor cultivation and giving strategy (see Standard 10.6). Documentation is to include FY 2023-24 audit, management letter (if available), the school's analysis of the FY 2024-25 operating revenues and expenditures to the date of the report's submission, and budget projections for FY 2025-26 and FY 2026-27 (see Standard 10.3).
