To require a report by the 1<sup>st</sup> of April 2026, on the financial operations of the school, including the FY 2025 audit, management letter (if available), the school's analysis of its FY 2026 operating revenues and expenditures, budget projections for FY 2027 and FY 2028, and a report on the school's progress toward reducing and eliminating its operating deficits (see Standard 10.3).

### Pentecostal Theological Seminary - Cleveland, TN

To require a report by the 1<sup>st</sup> of April 2026, on the financial operations of the school, including the FY 2025 audit, management letter (if available), the school's analysis of its FY 2026 operating revenues and expenditures, budget projections for FY 2027 and FY 2028, and a report on the school's progress toward reducing and eliminating its operating deficits (see Standard 10.3).

#### Presbyterian Theological Seminary in America of California Prestige University - Santa Fe Springs, CA

To require a report by the 1<sup>st</sup> of April 2026, regarding adequate financial resources, in light of cumulative losses in operations over the last three years, as reported in the school's most recent Annual Report Form. The report should include the FY 2025 audit, management letter (if available), the school's analysis of its FY 2026 operating revenues and expenditures, budget projections for FY 2027 and FY 2028, and a report on the school's progress toward reducing and eliminating its operating deficits (see Standard 10.3).

## The Seattle School of Theology and Psychology - Seattle, WA

To authorize an expansion of the focused visit to the school's new campus following relocation *from* 2501 Elliott Avenue, Seattle, WA 98133, *to* 1130 Rainier Avenue South, Seattle, WA 98144, (anticipated fall 2025) to address the school's financial condition, particularly in light of a pattern of operating losses and the deficit in undesignated net assets (see Standard 10.3).

### United Lutheran Seminary - Gettysburg, PA

1. To acknowledge notification that the school has been placed on warning by Middle States Commission on Higher Education (MSCHE) effective November 25, 2024, due to concerns related to educational effectiveness assessment.

2. To take no action at this time in light of the report due November 2, 2025, regarding the evaluation of personnel and the programmatic evaluation of student learning outcomes.

## ACTION TAKEN RELATED TO PUBLIC SANCTION (WARNING, PROBATION, OR SHOW CAUSE)

#### International Theological Seminary - West Covina, CA

- 1. To receive the report of the focused evaluation committee (spring 2025) and the interim report required by the Board in June 2023 related to strategic planning and probation on resources (financial).
- 2. To *extend for good cause* for one year (to June 2026) the probation on financial resources, as the school has demonstrated sufficient progress since the time the school was put on probation for finances two years ago. Progress has been made in the areas of strategic planning, cost-cutting measures, increased enrollment strategies, and increased donations but some of the initiatives still need to come to fuller fruition. The school must submit a report by the 1<sup>st</sup> of April 2026, demonstrating that the school meets Standard 10.3 and has "sufficient and stable financial resources to achieve its mission with educational quality and financial sustainability." The report should include the FY 2024 and FY 2025 audit reports, the school's analysis of its FY 2025 and FY 2026 operating revenues and expenditures, and a financial projection for FY 2027-2029 consistent with the school's strategic plan. The report should include a narration of the school's progress toward financial sustainability. Failure to meet the Standard at the end of the one-year Extension for Good Cause may lead to the Board withdrawing the school's accreditation (see *Policies and Procedures*, III.I).
- 3. To authorize a focused visit in spring of 2026, to make a recommendation regarding whether the Board of Commissioners should remove probation or take an adverse action, i.e., withdrawal of accreditation (see *Policies and Procedures*, III.J).

## Presbyterian Theological Seminary in America of California Prestige University - Santa Fe Springs, CA

- 1. To receive the report required in June 2023 regarding the warning related to Standards 9.6-8 on shared governance, specifically as it relates to the delegation of the governing body to the faculty appropriate authority to oversee, design, implement, evaluate, and improve the school's educational programs and policies in collaboration with other appropriate parties.
- 2. To remove the warning related to Standards 9.6-8.
- 3. To receive the report required in June 2023 regarding the warning related to Standards 2.6-7 on educational evaluation.
- 4. To remove the warning related to Standards 2.6-7 [i.e., the school is accredited in good standing].

#### Seminario Evangélico de Puerto Rico - San Juan, PR


- 1. To receive the report of the focused evaluation committee (spring 2025) and the interim report required by the Board in June 2023 related to the probation on resources (financial).
- 2. To extend for good cause for one year (to June 2026) the probation on financial resources, as the school has demonstrated sufficient progress since the time the school was put on probation for finances two years ago. Progress has been made in areas leading to initiatives for the generation of new income but some of them are still to come to fuller fruition. The school must submit a report by the 1<sup>st</sup> of November 2025, containing the audited report for FY 2024, demonstrating continual improvement toward financial sustainability. The report should also include the most recent FY 2025 budget vs. actual statement and the school's analysis of its FY 2025 operating revenues and expenditures, demonstrating diminishing dependency on non-recurring revenue sources and increased dependency on stable, recurring revenue sources (see Standard 10.3). Failure to meet the standard at the end of the one-year Extension for Good Cause may lead to the Board withdrawing the school's accreditation (see Policies and Procedures, III.I).
- 3. To authorize a focused visit in spring of 2026, to make a recommendation regarding whether the Board of Commissioners should remove probation or take an adverse action, i.e., withdrawal of accreditation (see *Policies and Procedures*, III.J).

## ACTION TAKEN RELATED TO PUBLIC SANCTION (WARNING, PROBATION, OR SHOW CAUSE)

### Interdenominational Theological Center - Atlanta, GA

- 1. To accept the teach-out plan required by the Board in February 2025.
- 2. To receive the report of the focused visit committee (spring 2025).
- 3. To impose probation for a period of 24 months (June 2025 to June 2027), as a result of the school not meeting the following Commission *Standards* (per *Policies and Procedures*, III.H): Standards 10.3, 10.5, and 10.7. The school does not have "sufficient and stable financial resources to achieve its mission with educational quality and financial sustainability." The school has not practiced protection and preservation endowed funds "including prudent endowment draws." The school has not employed "qualified persons sufficient in number to manage well its financial affairs." The school must submit the following reports:
  - a. a report by the 1st of April 2026, documenting progress toward financial sustainability, including a financial plan that is "realistic, wholistic, and sustainable" (see Self-Study Ideas for Standard 10.3 for additional guidance). The report must include: audits for FY 2024 and FY 2025, along with any management letters, budget to actual financial statements for FY 2026, projected budgets for FY 2027 and FY 2028, evidence of staffing appropriate for correction of deficiencies in internal controls, enrollment numbers for the previous two years, the current year, and projections for the next two years.
  - b. a report by the 1st of April 2027, documenting that the school has achieved financial sustainability. The report must include: the school's audit for FY 2026, along with any management letter, budget to actual financial statements for FY 2027, projected budgets for FY 2028 and FY 2029, fundraising through the ITC Foundation, the school's endowment spending policy, and the revised Consortium Agreement.
- 4. To affirm that the previously accepted teach-out plan meets the requirement for a school placed on probation.
- 5. To authorize a focused visit prior to the end of the period of probation (spring 2027) to make a recommendation regarding whether the Board of Commissioners should remove probation or take an adverse action, i.e., withdrawal of accreditation (*Policies and Procedures*, III.J).
