

Recipients named for latest *Pathways for Tomorrow* grants

ATS is pleased to announce the award of 118 Individual School Assessment and Planning Grants in January and February 2025 as part of the latest round of the Pathways



PATHWAYS *for* TOMORROW *Coordination Program*

for Tomorrow Initiative. These grants, designed to support ATS-accredited theological schools in the United States and Canada, aim to help theological schools strengthen and sustain their institutional capacities to prepare and support pastoral leaders for Christian churches.

The Pathways Individual School Assessment and Planning Grants were made available to theological schools that did not participate in the previous round of *Pathways for Tomorrow* Phase 2 grants. Each school is eligible to receive up to \$50,000 to engage in crucial conversations about leadership needs, explore insights from previous *Pathways* participants, and assess and design capacity-building projects. This round of awards totaled \$5,756,667 USD.

“These grants are a critical first step in helping institutions strategically evaluate their needs and opportunities,” said Jo Ann Deasy, ATS director of institutional initiatives. “By engaging in assessment and planning, schools are better positioned to implement transformative projects that will shape the future of theological education.”

Schools are using the funding to explore and plan initiatives related to increasing efficiency and lowering costs, strengthening financial models, expanding access to theological education, and partnering with churches and other faith-based organizations to recruit a new generation of leaders. The projects developed during this phase may serve as a foundation for future Individual School Imple-

mentation Grant proposals, which offer up to \$1 million in funding and are due by May 15, 2025.

Ongoing support from ATS

ATS leads the *Pathways for Tomorrow* Coordination Program in partnership with the In Trust Center for Theological Schools. Through ATS coordination, schools can take advantage of:

- **Monthly drop-in sessions:** Institutions can connect with Pathways personnel to discuss their projects and ask questions.
- **Recorded sessions and resources:** A continually curated and growing resource library to help schools understand key insights and best practices.
- **Email support:** Schools can reach out to pathways@ats.edu for guidance and assistance.

“We are committed to ensuring that every school has the resources and support needed to navigate the *Pathways for Tomorrow* grants successfully,” said Christopher The, ATS director of student research and initiative management. “Whether through drop-in sessions, email consultations, or access to peer learning communities, ATS is here to guide institutions every step of the way.”

The *Pathways for Tomorrow* Initiative is made possible through the generous support of Lilly Endowment Inc. Lilly Endowment has also provided funding to ATS and the In Trust Center to coordinate this work. ATS supports the

The In Trust Center provides resource consulting and plays a crucial role in peer learning and communications, helping to share the stories of how these grants impact theological education.

As we celebrate these new grants, ATS remains dedicated

to equipping theological schools with the tools and knowledge necessary to thrive in an ever-evolving educational landscape.
