

## COMMISSION'S STATEMENT OF ACCREDITED STATUS

Dallas Theological Seminary has been accredited by the Commission on Accreditation (COA) of The Association of Theological Schools since 1994. The school's accreditation was last reaffirmed in June 2014, based on an institutional self-study report and an onsite evaluation visit by a committee of peer and public reviewers. The school's next comprehensive evaluation visit will be in spring 2024, followed by a COA review for reaffirmation of accreditation in June 2024. The school's current period of accreditation expires July 31, 2024.

The school's current status of "Accredited in Good Standing" means the school meets all applicable COA Standards of Accreditation. The school demonstrates educational quality and financial stability and provides evidence that its student learning outcomes are appropriate, rigorous, and being achieved. The school has no public sanctions (notation/warning, probation, or show cause).

The school's ThM is approved as an exceptional and nonstandard use of the ThM nomenclature (January 1995).

On May 12, 2021, Commission staff granted temporary approval until the Board can act (anticipated: late September 2021; cf. *Policies and Procedures*, IV.E.2) thereby authorizing the school to close two additional locations currently approved to offer a complete degree, effective May 31, 2021: i) 1210 Franklin Road, Brentwood, TN 37027 and ii) 2533 Gosling Road, Spring, TX 77389. Both petitions were received May 11, 2021, with teach-out plans indicating that no students remain at either of the locations.
